## 5 - Deadlines for transmitting results to CSCQ

Usually, the deadline for transmitting the results to CSCQ is 2 weeks after shipping of samples (see the precise shipping date on the delivery sheet or on the results form).

For the OH survey (forensic medicine), the deadline for transmitting the results is 10 days. For the MD survey (forensic medicine), the deadline for transmitting the results is 31 days.
